Each would maintain their own zoning requirements. Ordinance creating a Joint Planning Commission will be coming in the near future. PCs will start working together this year. Possibly a short meeting discussing with other members of both PC members on May 91h. Village has 4 members now and still has one open seat. K. Samsel stated she would accept an appointment as representative from the counsel. D. Grossnickle Motion to appoint K. Samsel as council member to Planning Commision. J. Frizzell seconded. MC

There was discussion about new marijuana laws. You can either opt out/opt in/or do nothing. PC will not do anything until directed by the council. PC suggested that some workshops regarding same may be needed in order to get an understanding in order to proceed
