MINUTES: T. Covell made a motion to approve the minutes as amended. D. Peters seconded.

- J. Schafer discussed abandoning alleys. Asked what policies were in place regarding abandoning alleys. In processing of evaluating which ones need done. J. Nyrkkanen will give report to village president and then advise owners of decision. Will need to do a public hearing.
- J. Renwick wanted to clear that her husband is not using his jake brake.

REPORTS:

FIRE - just medical.

STREETS—proposal from Ron Brown to patch streets. **D. Grossnickle** motion to accept proposal and use village labor to do excavation at cost \$463. **J. McKinley** seconded. Motion carried. J. Nyrkkanen to call and tell them. Should look into a four way stop on Osmo to slow traffic down through village. J. McKinley to call for process for 4 way stops on village/county roads. Try to get enforcements during those peak times of it happening.

DPW – Sweeper repair. Leaks oil. May not be fixed by labor day. Need to call repair person. Discussed Park porta-potties. Need to get new quotes from other places.

PARK – Discussed cost of lights in Park. Who pays? See what the cost is to run them. Prices to remark campsites \$9.50 a piece for aluminum green and white. Discussed non-paying tent people. May need to put a note on tent.

WATER – Dixon Engineering hasn't returned the report with recommendations after inspection of tank yet. 200 customers over 6 million gallons in one month. 6 people were turned off for non-payment.

ZONING – needed policy of what to do if people don't mow and they have received a letter. Did D. Holtz talk to Wilson?

PLANNING COMMISSION – No meeting until September.

CORRESPONDENCE – Historical Society letter inviting people to the Sculpture ceremony September 4th 6:30 pm North End Centennial Walkway.
