She discussed the size and shape of new flower bed and materials she would like. There are left over stones at DPW that she can look at to see if she would like to use. Board has already approved budget of \$2500. She also discussed new benches for park. And lights on Centenial Walkway and also new way to light up sculpture was also discussed. The have \$1200.00 to donate toward this. And in future get water on walkway.

Discussed his neighbor putting up fence that he believes is partially on his land. Suggested he refer to his deed which will give him dimensions of his lot. D. Cummings and K. Somsel will check into this.

Reports: Fire-responded to house fire in Copemish. Grant for township for a fire truck. Board have E. Dufresne to work on this.

Streets - estimate provided for repair of road on Wuoksi Ave. Water will cover this because it was caused by water main break.

Chip and seal of roads in village list requested by J. McKinley to present to board next month.

Board approved E. Dufresne to apply for grant towards repair of S Aura St.

DPW-1) Benches are being worked on.

- 2) Location of trail cameras to be installed include recycling, trail, and dump station.

- 4)And with stumps gone it now opens 3 more sites for rustic camping. These will need to be assigned numbers.
- 5) Estimate for work to provide more sites with power. Cabinet has been picked up. Approximate cost to set up cabinet \$4800.00. Consumers energy will then run power to cabinet. Consumers energy cost have been paid. Motion to go forward with project by J. McKinley, seconded by D. Grossnickle. Motion carried.

Water- 1) need board approval for R. Schafer to enter contract with Verizon for phone number and hot spot for new IPad. Motion made by E. Dufresne, seconded by D. Grossnickle. Motion carried.

2) Construction on the Water project starts mid to late July. Funding signing is 20 April 2022.

Park-1) Pavillian needs new roof. Will start collecting bids.

2) Required board permission to receive funds from Friends of Kaleva for concession funds. A account has been set up to receive. Board approves.

Zoning- See attachment. D. Cummings also provided Court order giving village permission to clean up 14734 Sampo and file lien for cost of clean up against property. Police will accompany clean up crew to prevent any unpleasantness. Motion to approve hiring clean up crew made by E. Dufresne, seconded by D. Grossnickle. Motion carried.
